ORDER

Pursuant to Local Rule 21.6.2, it is hereby ordered that certain members of the Missouri Bar in good standing and who are experienced in juvenile court proceedings, as set forth in Exhibit "A", shall be appointed to serve as members of the Juvenile Court Advisory Panel. Members shall be appointed annually. Members shall serve on a rotational basis and shall have a six month respite generally after service of one year and shall continue to serve as a member of the panel, with their consent, until they are discharged by the Administrative Judge of the Family Court Division. The first group, Attorney Group A, shall begin their service on January 1, 2012 and shall serve through December 31, 2012.


Consistent with Local Rule 21.6.2, members of the advisory panel shall provide, without compensation, advice and consultation to members of the Missouri Bar appointed to serve as attorneys or guardians ad litem pursuant to Local Rule 21.6.1.
